**Entry Fees:** Fees for entries received by Saturday, October 3, 2015 are **\$15.00** for first entry of a dog and **\$10.00** for each additional entry same dog. There will be NO REFUNDS after October 3. All dogs welcome. Entries processed as received and email confirmations will be sent when email address is included on the entry form.

**Late & Day-of-Match Entries:** Entries received after October 3 are **\$18.00** per class. Limited Day-of-Match entries will be allowed **ONLY IF SPACE IS AVAILABLE**. Sign up between 8:00 AM and 10:00 AM, after which time entries are closed. Day-of-match entries will run after pre-entries.

Include a No. 10 Size Stamped Self-Addressed Envelope to receive judging schedule in the mail. Judging schedule will be posted online at [www.mddtc.org](http://www.mddtc.org) after Tuesday, October 6<sup>th</sup>, and entries including an email address will receive an emailed judging schedule. Entry lists will NOT be published online for protection of your privacy.

**Obedience Classes:** Rings will start at 8:30 AM. Two rings each level. Exhibitors are responsible for being at ringside for judging in numerical order. Sits & downs in separate ring.

**Rally Classes:** Rally ring will start at 9:00 AM with Excellent, followed by Advanced, then Novice. 10-minute course walk-through prior to each level. Limited to 50 total runs. Please specify class and jump height on entry form.

**Rules:** Corrections are limited to verbal corrections or gently guiding the dog. Collars should comply with AKC regulations; no prong or electric collars will be allowed. Toys and food are permitted, but no dropping of food in the rings. No refunds for dogs that do not exhibit. No refunds after closing date.
