# Notice To Exhibitors

- 1 Telegraph, telephone, unsigned, or incomplete entries cannot be accepted. Entries without fees are not acceptable. Entry MUST be made on an official AKC entry form with the AGREEMENT printed on the reverse side, or a photocopy of same. No entry shall be made, and no entry shall be accepted which specifies any conditions as to its acceptance.
- 2 Mail all entries and fees to Debra Hughes, 795 Camino Ricardo, Moraga, CA 94556 or email to VDTCsecretary2018@comcast.net. Entries must be received by deadline regardless of method.
- 3 Preferred method of payment is to <https://www.paypal.me/VDTC>. Membership not required.
- 4 CHANGES, additions, or corrections to entry forms must be received in writing prior to close of entries. Telephone changes are unacceptable. Changes may be emailed to the Trial Secretary, Debra Hughes.
- 5 FEES: A Recording Fee of \$.50 per dog and an Event Service Fee of \$3.00 per entry will be required for each dog entered in any Licensed or Member Club obedience or rally trial. These fees are to be collected by the trial-giving club and paid to the American Kennel Club. Each rally entry fee includes \$3.50 AKC Recording Fee on first entry and \$3.00 on each additional rally entry. There is a PayPal fee of \$2.50 for the first entry. The PayPal fee is subject to change without notice.
- 6 PLEASE TYPEWRITE or NEATLY PRINT all entries. Use black or blue ink; DO NOT use pencil or colored ink to write entries. It is preferred that you use an electronic form.
- 7 OWNERS or THEIR AGENTS ARE RESPONSIBLE FOR ERRORS on entry forms, for entering the same dog twice, or for entering a dog in a class in which the dog is ineligible to compete, regardless of who makes such errors. No Refund for Duplicate Entries. Every effort to find all duplicate entries will be made; however, if an entry has been processed, no refund will be made. An Administrative Fee of \$2.00 may be charged or withheld from refunds for duplicate entries or errors on entry blanks.
- 8 ANY CHECK RETURNED FOR INSUFFICIENT FUNDS will be charged a \$25.00 fee plus bank fees and must be paid in cash before the entry can be accepted. Subsequent returned checks from the same exhibitor or agent may result in being put on a cash-only basis. Returned Checks or Post-Dated Checks do not constitute a valid entry fee.
- 9 ENTRY FEES WILL NOT BE REFUNDED in event of errors or cancellation of entries after the published closing date and time, nor in the event a dog is absent, disqualified, sick, lame, excused by the Veterinarian or Judge, or barred from competition by the Show Committee. If, because of riots, civil disturbances, fire, Act of God, strikes, extreme weather conditions (including but not limited to extreme heat, floods, hurricanes, lightning, or earthquakes), or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fees will be made.(The exception is Bitches in season with a Veterinarian certification for Obedience/ Rally.)
- 10 CONFIRMATION OF ENTRY & SCHEDULE OF JUDGING TIME will be sent to the email address (preferred) or address on the Official AKC entry form after the closing date. If an exhibitor has not received a copy of the Schedule within seven days of the show, the Show Secretary should be contacted.
- 11 To find out about any AKC event cancellations call the AKC Event Cancellation Hotline (877) 252-3229.

**PLEASE NOTE**

No un-entered dogs, No crate aggressive dogs, No x-pens allowed in the building. Put crates on green mats only, bring water and a chair. It is safe to leave dogs in cars on the property, parking is close to the building. X-pens may be set up just outside the building under cover. Air dogs only on the gravel or in the dog run, not on any living plant or the green grass. Keep dogs away from the house area. This is ranch land, there are cows and feral cats, keep dogs on leash when not in the ring.
