Directions to Laurel Creek Park, Fairfield: Take Airbase Parkway exit #47 from I-80E or #47a from I-80W. Proceed east for 12 mi. to stop light at Dover Ave. Turn left on Dover, .5 mi to Cement Hill Ave. Turn right on Cement Hill for .7 mi to Laurel Creek Park. Park is on the left. When you enter the parking lot keep to the right and drive to the far end of the lot to the fenced ball field.

No awards will be given nor legs earned towards obedience or rally titles. Toys and food are permitted. Collars must comply with AKC regulations. No prong or electric collars are allowed. Corrections are limited to verbal corrections or gently guiding the dog.
